1. You may NOT photocopy scripts without explicit permission from Mysteries by Moushey, Inc. The only exception to this is in regard to AUDITIONS. Once you have ordered production materials you MAY photocopy **scenes** to use for auditions. **All script sales are final. By ordering production materials, you are liable for one performance royalty.**
2. We readily give permission to make script changes, including titles. You must, however, secure this permission, either through email or by phone or fax. We will require the exact "new" title, but changes within the script do not need to be specifically listed. Permission to make changes does NOT mean that you may use "adapted by" in your credits.
3. The following MUST appear in ALL of your promotional material, including programs, press releases, advertising, and WEB SITES. ABSOLUTELY NO EXCEPTIONS.

4. If you are unsure of your actual number of performances, give an estimate. Following your production, contact us and let us know the actual number, if different. We'll refund for cancelled performances - except the first one. BY ORDERING PRODUCTION MATERIALS YOU ARE LIABLE FOR THE FIRST PERFORMANCE ROYALTY OF \$100. **It is your responsibility to contact us if you ADD PERFORMANCES and you are liable for royalties for those performances - \$75 per.**
5. Production packages include supplemental materials to help with your production, as well as a Production Manual for how to put it all together! The Production Manual is the same for all shows, so it is sent with first-time orders only - hang on to it!
6. No information provided to Mysteries by Moushey, Inc. will be sold or otherwise disseminated in any way. The email address you provide will be used exclusively by Mysteries by Moushey, Inc. for correspondence purposes. Besides inquiries regarding individual orders, Mysteries by Moushey will send out a newsletter several times a year with special offers, updates on scripts, etc. If you do not wish to receive these, you may "opt out" the first time you receive one.
